Origin of the Correspondence. General Scott first saw, at his quarters, in New York, about the last of May, 1817, the celebrated order. He read it in histe, and does not recollect to have made any particular remark on it at that time.

About the 9th of June following, general Scott went to dine at a private house, where he met a highly respectable family and company, and among the guests the governor elect, of the state. By this time, the order had been printed in all the city papers, and was, as will be remembered, the leading topic every where -It soon became the subect of conversation (before dinner) between the governor and general Scott, who were seated near each other. The governor thought the order mutinous, and gen. Scott felt himself called upon, by the turn of conversation, if not expressly invited (which is his belief) to state, professionally, what were the principles involved in the question raised by general Jackson with the war department

His opinions and his illustrations, or i other words what was said by him, at the time, and on two other occasions, (the one before the other after the 14th of August) will be found in substance, and almost literally, in the second letter of the series. This conversation was, no doubt, partially overheard, by one or two other guests, though conducted in the ordinary tone, and not ob-

LETTER II. General Scott to General Jackson.

Head quarters 1st and 3d military departments, New York, Oct 4th, 1817. SIR-I have the honor to acknowledge the recept of your letter of the 8th ultimo, together with the two papers therein inclosed.

I am not the author of the miserable and unmeaning article copied from "The Columbian," and (not being a reader of that Ga? zette) should probably never have heard of it, but for the copy you have sent me. And whilst on the subject of writing and publishing, it may save time to say, at once, that with the exceptation of the substance of two articles which appeared in "The Enquirer" last fall, and a journal kept whilst a prisoner in the hands of the enemy, I have not written, nor caused any other to write a single line for any gazette whatever, since the commencement of the late war.

Conversing with some two or three private gentlemen, about as many times, on the subject of the Division order, dated at Nashville, April 22d, 1817; it is true that I To Maj. Gen. WASHINGTON, APRIL 8. FIRES .- A fire broke out in I street in this city, in the square on this side of the Frankin Hotel, between 5 and 6 o'clock yesterday afternoon. Four or five small dwelling houses were burnt down before the progress of the fire was arrested.

APRIL 10. We have had for the 30 or 40 hours, ending at 5 o'clock yesterday, a gale of wind from the North West, of unusual violence as

Heretofore our city has been providen. tially exempted from the casualty of Fire. Alarms of that description have, however, within a few days, been so frequent, as to warn us to greater vigilance and caution.

We have already noticed the fire on I street north, in which three or four small houses were destroyed, between 5 and 6 o'clock on Wednesday evening These houses belonged to widows McKeldon and Kedgelie, and others. On Tuesday afternoon, about the same hour, the alarm of fire was given from the eastern part of the city, and three or four small brick and frame houses, the property of Mr. Law, Mr. Taylor, and others, on N. It then continued down Talbot street to the creek, where, on blowing up the house of Mr. Broughton, (the junior editor of the Herald) its ravages were here stopped also. It was about 3 o'clock this morning before it was got under. No lives were lost and I believe no serious accident happened. 'The loss in property is very considerable, its extent not yet known. The occupiers of houses on Main street were principally store or shop keepers, and probably had nearly their all in their houses at the time the fire broke out Considerable quantities of goods that

were saved from the fire were either destroyed in moving, or pilfered by abandoned wretches after they had been deposited in places of safety; although, to prevent depredations of this kind, guards were placed around, to protect them. But it would have been impossible for the guards to have overlooked all; they did all that it was practible for them to do. I have only time to close this sketch, as the steam boat Roanoke is just starting; but the papers hereafter will give you further particulars.

RICHMOND, VA. APRIL 6. LIMING SEED WHEAT.

A respectable correspondent informs us, that unslacked lime has been found to an swer an excellent purpose, in preparing wheat for seed. The gentleman states that he put about four or five pounds of quick lime into a sufficient quantity of water to soak one bushel of wheat, which he sowed the last spring, then added the wheat, and permitted it to remain about 12 hours. The lime by slacking, raised the temperature of the water to blood he t, and the wheat became soft and apparently par boiled. On sowing it, however, it sprouted much sooner than usual, flourished remarkably, and produced an excellent crop, entirely free from any appearance of smut. The above is probably the least expensive, and most efficacious mode of preparing wheat for seed, that has yet been discovered.

THE FLORIDAS It is believed, for our knowledge of the Floridas is very defective, that few, if any of the navigable rivers take their rise in the United States; but the coast is indented with two spacious bays that will afford security for shipping: particularly the large and ca-pacious bay of Hillsborough, which will admit any vessel over the bar, not drawing more than twenty-four feet water. The principal part of the soil in the peninsula abounds in pines, called the yellow pitch pine tree, which is excellent timber for shipping: the peach and the mulberry orchards, thrive in this soil remarkably well: it is likewise abundant in grass. In the vicinity of the soil so productive of the pine, there is to be found soil of another quality: it abounds in maple oak of seven different species, all of which grow in great abundance; walnuts, chesnuts, mulberry and maple; it is likewise favorable to the cultivation of the indigo plant: figs and oranges are likewise Harper's Ferry. found in this soil; but the latter fruit is not of the first quality.-Nor are the savannahs of Floridas destitute of interest, although in the wet seasons they are almost impassible; vet they are productive of grass of which cattle are extremely fond; in this soil dwarf oaks and junipers are numerous. No reply has ever been given to the roregoing, and of course general Scott has never seen the original anonymous letter. His suspicions and the whole correspondence were fully communicated in January, 1818, to a particular friend of governor Clinton, who was perfectly at liberty to give notice thereof to that personage. Whether he did so or not general Scott is not informed. A copy of the correspondence whould have been sent to Mr. Clinton, but for the prohibitory regulation above cited, and which came out before general Jackson had had time to reply to the letter, if he had been so disposed. General Scott, until his opponent had set him the example (a precedent not disapproved by the War Department) supposed that the first sentence of the regulation "all publications," &c. interdicted manuscript copies as well as others. Until then a distinction of this sort appeared to him absurd: for how easy would it be for any of the numerous persons to whom general Jackson has delivered
