' His new house, which is close to his present residence, is nearly finished and will be fit for his reception in or about three or four months, if the furniture, &c. arrive in due time from England. It is a substantial building, all on one floor, and the different suites of apartments are really handsome and commodious .- He has a carriage and horses at his command, and he can now ride, without any restriction or attendant, within a space upwards of twelve miles in circumfe-rence, with variety of hill and dale, but not well wooded; however, all will not induce him to mount a horse or carriage. 
