ARRIVAL OF THE GREAT WESTERN.

Very Late from England. TWENTY-ONE DAYS LATER FROM LIVERPOOL.

The Great Western, besides a valuable cargo of silks, &c., has brought out two millions of dollars in specie, for the British service in Canada.

The Great Western has also brought out 128 passengers, among whom are the Bishop of Toronto, Major Van Buren (son of the President), and Lady; his Excellency Baron Roussier of St. Paul.

The Western has also made a small gain in specie in 13 days, the same time occupied by the Great Western from Liverpool to New York.

The Bank of England, it appears, cannot issue small notes without permission of Parliament.
