





Of this amount \$17,-254,470 were in gold, and \$6,032.075 in silver. This is greater, by about \$6,000 000, than the imports of any year since 1821. The amount exported in 1843 was \$3,118,399. This table shows a gratifying increase of the precious metals in the country, which will tend still further to give stability to our currency.






