SWARTWOUTING IN OHIO,

The Locofeco office holders in Ohio have been laving the game of "grab and hold-fast" with a vengeance. The Board of Public Works, like the one in Pennsylvaniz, has been used for the purposes of party and richly indeed have some of the party profited by their connexion with it. The Ohio State Journal furnishes a list of these eculators, and says they are facts which can be verified by an examination of the papers and records of the public offices. First in the lis comes Timothy Bates, who was appointed in the spring of 1837, and turned out by the Whigs in April, 1838, and re-appointed by a Locofoco majority in April, 1539. When Bates was :nrned out the 1st of April, 1838, he was a defaulter in the sum of seven thousand nine hundred and forty three dollars and seventy three cents ; and when he was re-appointed in April, 1839, he had not paid one cent of this sum ; and the books in the public offices showed that he was a defaulter .-When Bates left the office in April, 1842, the books show a second balance against him of \$5,-582 84 ; making in all the sum of thirteen thousand five hundred and twenty six dollars and fiftyseren cents of the people's moticy in the hands of Mr. Bates, appropriated to his own or the par-
