



## COMMON SCHOOLS.

#### We have somewhat to say upon this subject in addition to the remarks airendy given, and beg our eaders to hetr us ont.

In order to secure a more efficient enforcement of the law authorizing and establishing our commonschool system, we respectively submit whether a regular monthly meeting of the Commissioners would not be advisable.

One of the duties of the Board is the selection and employment of compttent Teachers to take charge of the schools. And how can this be done effectually, unless they have regular and stated periods for meeting at the county-seat ! As it is, but one or two of the gentlemen comprising the Board are ever aware of the selection of a Teacher rovernment until be is confirmed by them, which must be done ere his salury can be paid him. We submit it

then, that upon so important a duty as selecting and examining Teachers, the whole board should be in session. The examination might be conduct. ed in private, when the applicant prefess it, but always by a standing committee regularly constituted for that purpose, at the first meeting after the election of Commissioners.

These examinations in the neighboring county of Frederick. Maryland, are held annually in the presence of the entire board of Inspectors-and are rather more thorough than those usually given to applicants in our own county. When this ordeal s passed with due credit to those applying, and satsfactorily to the examining committee, it it should e approved by the Board in regular session, a certificate to that effect should be made out, properly signed by the officers of the same, tendered to the successive candidate. These certificates should be renewed at each annual meeting of the Commissioners, they being presented as vouchers. They should be divided into three or more grades, according to the branches in which the Teacher is ound proficient. For instance,-the ordinary branches might be recognized as the first grade :-

these, including Algebra, Geometry and Surveying, as the second-and the classics and higher branches of the Mathematics; as the third-each certificate stating distinctly the branches which the applicant is found competent to teach. This plan, if properly carried out, will be of great benefit to the interesting class of young men who are engaged in teaching, ensuring them a fair appreciation of merit and qualification, and at the same time acting as a stimulus to the entire body to excel in their different studies, and thus effectu-
