ANOTHER CANDIDATE.

The preliminary canvass for Governor is becoming active, although the election will not take place until May 1859, and a year hence. A Legislative Association presents the name of Pauline Powell, Esq., the present representative in Congress from the Anner district, a very modest but sensible Democrat, who has never attempted any display in Congress, but is always found "right side up" with his party. We agree with the Petersburg Intelligencer, however, that his friends had made a capital blunder in appointing Mr. P. for never having been anything but a Democrat. JOHN J. CRITTENDEN.

John J. Crittenden entered the Senate of the United States in 1817, forty one years ago. In that long period, says the Cincinnati Commercial, he has been one of the most conspicuous, consistent, and able of American statesmen. Presidents have gone in and out of office, without not half his renown, nor a fourth of his ability. Less brilliant than many, his practical sagacity is almost unequalled. Belonging to the conservative party, and coming from a central State, he has gone to no extremes. He has been twice in the Cabinet, but has never been charged with the least of office. All manner of corruption has been seen in high places, but the breath of slander has never whispered it of him. The people of his own State have valued these high qualities: From 1817 to 1819; from 1835 to 1841; from 1842 to 1849; and from 1858 to the present time, he has been in the United States Senate. In 1840 he became a member of Gen. Harrison's Cabinet, and in 1850, of Mr. Fillmore's. His present term of service in the Senate will expire in 1861, forty four years from the time he entered that body, and twenty one years, in all, of Senate service. Supposing him to have been only of constitutional age when he entered the Senate, he must now be seventy one years of age—yet hale in strength, and honorable among the conscript fathers of the country.

MR. CRITTENDEN IN CINCINNATI.

In the course of his speech delivered at Cincinnati, at the recent welcome given to him in that city, Mr. Crittenden said: "There had been rumors of war, but there remains no danger of any with Great Britain. We have only to cultivate peace, and all those disturbing and perplexing questions of treacherous portent will vanish into nothingness. He congratulated the people that the fury of partisan strife is subsiding. He thought there could not be much of a contest which is preparing for the future, when the people shall again choose a President. 'Not much of a contest, I think,' said he, with a prodigious grin which brought down the house. 'An administration that begins by spending \$17,000,000 of surplus, spends \$20,000,000 more of treasury notes in addition at the start, borrows \$20,000,000 more during its first year, and forces us at the expiration of a year an expenditure of \$40,000,000 with-out a cent of our own money for the next year can't stand long in the favor of the people.' He would frankly admit that Mr. Buchanan came to the Presidency at an unlucky time, and he had had an unlucky time of it. The country had suffered great social distress; commerce was depressed; and it was some what owing to these calamities that the deficiency in the national exchequer exists. But still the Administration is chargeable with extravagance, and the inevitable consequence is a great national debt. When it is remembered that the administration of the younger Adams was denominated as extravagant when the entire expenditure for four years was only \$54,000,000 and that of Jackson, whose bill of costs for a similar period was \$100,000,000, what will be the conclusion of the American people when they outside \$60,000,000 expended by the Buchanan administration in a single year? It is enough to make the people study very closely."
